The rented room is a single room double room for 2 persons.

The room may be used only as dwelling for the Tenant(s) Pets are not allowed.

The Tenant may use the assigned Kitchen ___ If the Tenant do not clean up after one selves in the assigned Kitchen and common areas the Tenant will be fined with DKK 750/EURO 100.

Furthermore, the Tenant has the right to use these facilities in accordance with UC House instructions:

Laundry facilities, Living room/common areas and bathrooms

The Rental Period:

This agreement takes effect on date _____ The minimum rental period is 6 months. The Tenant can give notice after the minimum rental period with 3 months written notice on the last working day in any one month. If the Tenant gives notice before the minimum rental period the deposit will not be refunded. A rental month is a full month from 1st – 30th. If the study ends or if the Tenant is no longer a student, the student must move from UC House within 4 months if UC House is demanding this. UC House can at any time ask the Tenant to

confirm the education relationship. The tenant agreement expires after 3 months given notice. Please note that when you have terminated your education you still have to give 3 months notice before moving out.

Payment and other Financial Considerations:

The monthly rent amounts to DKK _____ pr. Tenant.

The monthly rental amount is divided into rent DKK _____ + consumption of electricity, water and heating DKK 500.

Tenants pay 1/65 of the cost of consumption on electricity, water and heating. Every 12 months there will be made a complete consumption accounting, and will be regulated after this.

In case a Tenant has an extra ordinary use of electricity, water and heating UC House is allowed to install individual watches and/or make an individual agreement with the Tenant on the use.

Wi-Fi Internet is available for free for normal use. The Landlord will refuse access to the Wi-Fi Internet for the Tenant if the monthly rent is not duly paid.

The rent will be regulated against the net price index, with no less than 3% per year.

If the room is used as a double room, and one of the tenants wants to leave, the status of the room changes automatically to a single room, and the rent will be regulated here for.

The rent is payable in advance *no later than the last banking day of the month* to the following account no. :

There will be an additional charge if the rent is not paid in due time, with DKK 100 pr. week overdue pr. rent. The charges will be summed until the rent is paid in full, and added to the rent of the following month.

Deposit in the amount of DKK _____ has to be paid before date: _____. The deposit is equal to two month's rent, and is a security of the Tenant's obligations after moving, such as cleaning, repairs and maintenance, and such cannot be used as payment for rent.

Room condition at check in and check out:The room will be well kept and in good repair. The room is furnished with at bed, a computer table, a lamp and a chair pr. tenant. The room and the furniture are to be kept in the same condition when the tenant leaves. The Tenant is

obliged to keep the room properly cleaned. For the duration of the tenancy UC House is entitled to inspect the room.

The Tenant is obliged to participate in keeping the common areas, such as bathrooms, kitchens and living rooms clean and tidy after the Landlords instructions. If the Tenant refuses, the Landlord can hire cleaners for the tenant's expense or ask the tenant to leave the premises of UC House with out additional warning.

The Tenant must arrange that the room is inspected at check out. In connection with check out the Tenant must leave the room in the same condition as when checking in. The Tenant's will be charged with DKK 1000/EURO 130 for administrative costs. If the walls need to be painted, this will be charged with DKK 250/EURO 35 pr. wall at the Tenant's expense. Damaged furniture will be replaced at the Tenant's expense.

Other terms:

The Tenant has received the UC House Rules and Regulations and a copy of this contract. In case of negligence or failure to observe the contractual agreements UC House is entitled to cancel the contract. The Danish Rental Act does not apply for this rental contract.

For Replacement of lost key the Tenant will be charged DKK 200/EURO 30

If the drains are clogged because of misuse, such as using the bathroom sink or WC for waste disposal, the Tenant will be charged DKK 300/EURO 40, to get it cleansed.

Smoking inside the building is not allowed though Danish law and will be fined with DKK 750/EURO 100

If the Tenant do not clean up after you in the assigned Kitchen, Living Room and common areas the Tenant will be fined with DKK 750/EURO 100.

If the fire alarm is set off with no due cause, the Tenant will be charged DKK 7.500/EURO 1.000

Violations to the above can cause immediately eviction.
